### End User License Agreement ("EULA")

This End User License Agreement ("Agreement") is an agreement between JCL CREDIT LEASING SDN BHD (413411-H), (hereinafter referred to as "JCL," the Company," "we," "us" or "our") and you or the entity that you represent for the J-CLicks software (hereinafter referred to as the "Software").

#### 1. <u>Software License</u>

Subject to the terms and conditions of this Agreement and during the term of this Agreement, JCL hereby grants you a non-exclusive, non-sublicensable, non-transferable license to install, access, download and use one copy of the Software in object code form only on an authorized personal computing device and network server solely to use the services made available by JCL (the "JCL's Services") for your own personal or internal business use (the "Permitted Purpose"). Any Software that updates, supplements or replaces the original Software is governed by this Agreement unless separate license terms accompany such update, supplement or replacement, in which case such separate terms will govern in the event of a conflict with this Agreement or as otherwise provided in such separate terms.

#### 2. <u>License Limitations</u>

Section 1 states the entirety of your rights with respect to the Software, and we reserve all rights not expressly granted to you in this Agreement. Without limiting the foregoing, you will not do, or authorize or permit any third party to do, any of the following:

Unless expressly prohibited by local law, this Agreement is governed by the laws of Malaysia, without regard to any conflict of law principles to the contrary. You hereby irrevocably consent to jurisdiction of the state and federal courts located in Malaysia with respect to any proceeding regarding this Agreement or the Software. You will not prosecute any action, suit, proceeding or claim arising under or by reason of this Agreement or the Software except in such courts.

#### 11. <u>General</u>

#### (a) Export Restrictions

The Software is subject to all applicable export restrictions.
